I welcome you all to the general Body Meeting of the Forum for Global Knowledge Sharing (Knowledge Forum). Since April 2011 we have made considerable progress in publications. We have added about 31 new research papers in our "*Research Papers*" folder. We also have three volumes published this year. #### **Financial Position and Audited Statement**

As you can see from our audit statement, we have invested the entire membership fee (including corporate members) in fixed deposits. Till 2010 our expenditures have been very modest. Our host institutions took care of all expenditures. They also directly received grants from other agencies. Knowledge Forum did not receive any grant. With respect to funding, 2011 Annual Conference was different and our collaborators, namely, TIFAC and IASSI transferred funds directly to Knowledge Forum. All expenditures of the VI annual conference were incurred by Knowledge Forum. The audit statement reflects this.

Professor K Narayan, Treasurer of Knowledge Forum and Convenor of our conferences, is mainly responsible for organising Goa and Pune conferences. He identified the host institutions, negotiated with the funding agencies and obtained resources. I was only giving him moral support. It is getting increasingly difficult to motivate industry and government agencies to fund conferences. As I have been emphasising in my earlier Annual Reports, we need to build a good corpus (endowment) to meet our modest expenditures. We need to be in a position to rely at least partly on our own resources to conduct our annual conferences and not depend entirely on host institutions and other funding agencies. I appeal to the members of the General Body to help us in this fund mobilising endeavour.
