*Report of the Secretary* (October 27, 2014)

I welcome you all to the general Body Meeting of the Forum for Global Knowledge Sharing (Knowledge Forum).

Before presenting the report I would like to place on record our deep sorrow on the death of Professor Daniel Van Den Bulcke. He has been a Vice-President of our Forum for Global Knowledge Sharing since its inception. He has been regularly participating and contributing papers in our conferences. He has also been motivating young European Scholars to become members of the Forum. His death is a big loss to the Forum. He took active part in our last year conference (October 25-27, 2013) and chaired a Session and discussed a large number of papers. Within two months of attending our conference he died. We will always cherish his memory.

#### **Report on activities: Since April 2013**

Since April 2013 we have made considerable progress in publications. We have added about 26 new research papers in our "*Research Papers*" folder. In addition we have new "*Case Studies*". Select papers presented in our 2013 annual conference held at IIT Bombay have been accepted for publication by *Springer*. This will appear as an edited volume.

#### **Financial Position and Audited Statement**

As you can see from our audit statement, we have invested the entire membership fee (including corporate members) in fixed deposits. We now have about Rs.5,69,252 in fixed deposits. Last year interest from fixed deposits came to only about 63,816 rupees. Therefore for holding our annual conferences we have to depend on external sources of finance. The 2013 conference was funded by K U Leuven Belgium. The money was transferred directly to IIT Bombay. For the current conference we have received Rs.5 lakhs from INAE. In addition ISRO and DST have directly transferred funds to NIAS for local hospitality and other conference related expenditures. INAE has agreed to support our next two conferences also.
